High Adventure Awaits in the Mountains of New Mexico!



The Central Minnesota Council has a total of 12 spots available for Boy Scouts, Venturers and adult leaders for the 2013 Philmont Trek. This is a once in a lifetime opportunity that can be the pinnacle of a boy's Scouting career. Each year approximately 20,000 Scouts and leaders hike the 137,000 acres of Philmont property located in the foothills of the Rocky Mountains in New Mexico.

At least two adults will be required for the Crew in order to comply with BSA Youth Protection standards.

Trek Dates:

Arrive at Philmont: June 17, 2013

Depart Philmont: June 29, 2013

Cost: \$800 per person (*this does not include transportation to or from Philmont Scout Ranch*)

Additional Requirements:

- All participants must complete a full health form including physical.
- All participants must meet the Height and Weight requirements (found in Part D of the BSA Health Form). Anyone who shows up at Philmont not meeting these requirements will not be allowed on trail and will be sent home.
- At least one adult per Crew needs to have completed Wilderness First Aid training.
- A deposit of \$100.00 per person is required by April 24, 2012. Deposits are non-refundable, unless **you** secure a replacement for your spot.
- All Scouts must be at least 14 years old by January 1, 2013 or have completed 8th Grade by June 10th, 2013.
- All Scouts must hold the rank of First Class or higher and have Scoutmaster or Crew Advisor approval.

Philmont Payment Schedule:

- Deposit of \$100 Due April 24th, 2012
- Payment of \$350 Due September 27th, 2012
- Payment of \$350 Due February 25th, 2013
