



# CAMPING SCHOLARSHIP APPLICATION



A summer camping experience is the highlight of a youth's year in the Scouting program. The Central Minnesota Council, Boy Scouts of America has a limited number of dollars available [from Friends of Scouting, Council Popcorn Sale, and United Way] to fund a Camping Scholarship program enabling more Scouts to participate in camp.

Camping Scholarships may cover up to one half of the youth's Summer Camping fees. Scholarships are limited to Cub Scouts, Boy Scouts, and Venturers registered in Central Minnesota Council units. The Scholarship Program applies toward CMC Day Camps, CMC Cub Resident Camp, CMC Webelos Resident Camp, and Boy Scout Camps administered by neighboring councils.

The Scholarship Program is not available for Troop camping trips, District or Council Activities, High Adventure Trips, or National BSA Events.

Please complete the information and obtain the approvals requested below. Camperships are based on need and availability of funds. Applications must be received at least four weeks prior to the camp date to allow for approvals, notification, and transfer of funds.
